This Agency filed a full report.

The chief administrator affirms that the Amarillo Police Department has a policy in place in accordance with Texas Code of Criminal Procedure §2.132, and that the policy;

- (1) Clearly defines acts constituting racial profiling;
- (2) Strictly prohibits peace officers employed by the Amarillo Police Department from engaging in racial profiling;
- (3) Implements a process by which an individual may file a complaint with the Amarillo Police Department if the individual believes that a peace officer employed by the department has engaged in racial profiling with respect to the individual;
- (4) Provides public education relating to the agency's compliment and complaint process, including providing the telephone number, mailing address, and email address to make a compliment or complaint with respect to each ticket, citation or warning issued by a peace officer;
- (5) Requires appropriate corrective action to be taken against a peace officer employed by the Amarillo Police Department who, after an investigation, is shown to have engaged in racial profiling in violation of the Amarillo Police Department policy adopted under this article;

(6) Requires collection of information relating to motor vehicle stops in which a ticket,

citation, or warning is issued and to arrests made as a result of those stops, including

information relating to:

a. The race or ethnicity of the individual detained;

b. Whether a search was conducted and, if so, whether the individual detained

consented to the search:

c. Whether the peace officer knew the race or ethnicity of the individual

detained before detaining that individual; and

d. Whether the peace officer used physical force that resulted in bodily injury, as

that term is defined by Section 1.07, Penal Code, during the stop;

e. The location of the stop; and

f. The reason for the stop; and

(7) Requires the chief administrator of the agency, regardless of whether the

administrator is elected, employed, or appointed, to submit an annual report of the

information collected under Subdivision (6) to:

a. The Texas Commission of Law Enforcement; and

b. The governing body of each county or municipality served by the agency, if

the agency is an agency of a county, municipality, or other political

subdivision of the state.



1. Total Traffic Stops

Amarillo police officers made 33,293 motor vehicle stops in 2022. The primary reason for a motor vehicle stop was a traffic violation such as speeding, an illegal turn, or other observed violation of Texas motor vehicle laws. Motor vehicle stops decreased approximately 11.6% from 2021 to 2022.



Citing the reason for the stop, 547 were a violation of law, 224 where the officer had pre-existing knowledge of a warrant or crime, 27,486 were moving traffic violations, and 5036 were other vehicle violations.






Chart 8c: Probable Cause = 57





Chart 8d: Inventory = 11







Chart 9b: Was Contraband Discovered-NO





Chart 10b: Currency = 1




Chart 10d: Alcohol = 13

b. Violation of Traffic Law = 12








